OPEN TOURNAMENT RULES

1. Entries are open to all members of the Greater Charleston USBC Association.
2. All prize fees will be returned 100% in each division.
3. Entrants will use their **highest** USBC average as a regular bowler or a substitute bowler in the following order:
 - End of the 2010-2011 winter season: 21 games or more
 - End of the 2011 summer season: 21 games or more
 - December 31, 2011 average: 21 games or more (League Standing sheet or note from league secretary)

Team captains are responsible for reporting accurate and verifiable averages for their team members. Submitted averages will be used unless a higher average is found to fit the criteria above.

4. Handicap will be based on 80% of 220.
5. Teams in this tournament will consist of four (4) members. Prizes will be awarded on a handicap basis. Scratch team, doubles, singles and Scratch all-events awards will be given, provided the Scratch event fee has been paid.
6. There will be one (1) prize for each ten (10) entries in Handicap and Scratch Team, Doubles, and Singles. Handicap and Scratch All-Events will pay one (1) prize for each twenty (20) entries. Scratch prizes will be available for an additional \$5.00 per event per person i.e., an additional \$20.00 for all Scratch events per person. **All members of a team or both members of a doubles pair must pay to be eligible for the Team and Doubles Scratch prizes, respectively. Bowlers must be entered in the handicap division in order to enter the Scratch division, including All-Events.**

A thirty dollar (\$30.00) fee will be charged for any check returned for nonpayment.

7. Entries received by the reserved entry date of **February 25, 2012** (postmark date) will have the best chance of being scheduled on their first choice of squads. Walk-in entries must be present one hour prior to squad time to verify lane availability with the tournament director. Bowlers may reenter as many times as desired subject to USBC Rule 315. Team event: no more than two (2) players on one (1) team can place more than once in the prize list for position standings. Doubles event: in no case will the same two (2) players on a doubles pair be permitted to place more than once in the prize list for position standings. Singles event: in no case will the same individual be permitted to place more than once in the prize list for position standings.
8. If entered in doubles, bowlers must also enter in singles and vice-versa on their original entry.
9. Team Captains must check in their teams thirty (30) minutes prior to their scheduled time to bowl.
10. If a bowler is late, the bowler receives a score of zero (0) for each frame missed. A substitute may be entered at this time. Substitutes will bowl in the position of the bowler being replaced.
11. The Board of Directors of the Greater Charleston USBC Association will have the right to hear and decide on all protests arising during the tournament. Any protest affecting eligibility or playing rules must be confirmed in writing within twenty-four (24) hours.
12. The 10-pin rule does not apply to this tournament (Rule 319.a2).
13. The tournament will be divided into two (2) divisions as follows:
 - Division A: Team whose combined average is 720 and above, Doubles 360 and above, Singles 180 and above.**
 - Division B: Team whose combined average is 719 and below, Doubles 359 and below, Singles 179 and below**
14. Proper attire should be worn. Shorts will be allowed provided they are of a proper length. Holes and tears in clothing will not be allowed. No cell phones or other electronic devices during competition. No headgear unless medically necessary."
