## The GCUSBCA Youth Alumni Tournament Rules

1. The Youth Alumni Tournament will be certified with the US Bowling Congress (USBC) and USBC rules will govern except as noted below.
2. Sanctioned bowlers for league year 2021-2022 who were members of the Greater Charleston USBC Association when they graduated from high school are eligible to participate.
3. Bowlers who graduated between the years of 2014-2021 ONLY are eligible to participate.
4. There will be two divisions: Male and Female.
5. All bowling will be on a scratch basis.
6. Event Format
a. Qualifying
i. Each participant will bowl 6 qualifying games with total pin fall determining the standings.
ii. Each participant will move 1 pair of lanes to the right after each game.
iii. At the completion of the $6^{\text {th }}$ game, the field in each division will be cut to 4 players for a bracket style championship. The seeding for the bracket championship will be determined by total pinfall during the 6 games of qualifying.
7. If there is a tie for any position $1-4, \mathrm{a} 9^{\text {th }}-10^{\text {th }}$ frame roll-off will be bowled until the tie is broken.
b. Bracket Championship
i. In each division, the top 4 seeds will bowl a bracket roll-off.
8. Match 1
a. Seed \#1 vs. Seed \#4
b. Seed \#2 vs. Seed \#3
c. Ties shall be broken by a $9^{\text {th }}-10^{\text {th }}$ frame roll-off
9. Championship Match
a. The winner of \#1 vs. \#4 match will compete against the winner of \#2 vs. \#3 match for $1^{\text {st }}$ and $2^{\text {nd }}$ Places.
b. The highest score of the non-winners of Match 1 will be awarded $3{ }^{\text {rd }}$ Place.
c. All ties shall be broken by a $9^{\text {th }}-10^{\text {th }}$ frame roll-off
10. Prizes
a. Prize funds will be awarded in the form of scholarships and deposited to SMART accounts
b. Prize funds will be awarded on a $1: 4$ ratio.
11. All funds will be returned $100 \%$ to the prize fund after lineage and expenses are paid.
12. The Event Director/Designated Representative has the authority to disqualify any contestant for unsportsmanlike conduct or improper attitude during tournament play. The Event Director/Designated Representative will make decisions regarding tournament play based upon USBC tournament rules.
13. All rules not covered above shall be enforced based upon the 2021-2022 USBC Rulebook.
