## WOMEN'S TOURNAMENT RULES

1. Entries are open to all female members of the Greater Charleston USBC Association.
2. All prize fees will be returned $100 \%$ in each division.
3. Entrants will use the highest USBC average in the following order:

- End of the 2021-2022 winter season - 21 games or more
- End of the 2022 summer season - 21 games or more
- December 31, 2022 average - 21 games or more (League standing sheet or verification by League Secretary)
Team captains are responsible for reporting accurate and verifiable averages for their team members. Submitted averages will be used unless a higher average is found to fit the criteria above. If any member of the team has EVER been re-rated at ANY tournament, that re-rate MUST be declared.

4. Handicap will be based on $90 \%$ and 210 .
5. Teams in this tournament will consist of four (4) members. Prizes will be awarded on a handicap basis. Scratch Team, Doubles, Singles and Scratch All Events awards will be given provided the Scratch event fee has been paid.
6. There will be one (1) prize for each 3 entries in Handicap and Scratch Team, Doubles and Singles. Handicap and Scratch All Events will pay one (1) prize for every 8 entries.
7. Scratch event prizes will be available for an additional $\$ 5.00$ per bowler per event, $\$ 20.00$ per bowler for all 4 events. All members of a team or both members of a doubles pair must pay to be eligible for the scratch prizes. Bowlers must be entered in the handicap division in order to enter the scratch division including All Events.
8. Entries received by the reserved entry date of March 18, 2023 will have the best chance of being scheduled on their first choice of squads. Walk-in entries must be present 30 minutes prior to squad time to verify lane availability with the tournament director. Bowlers may re-enter as many times as desired subject to lane availability. Multiple participation Rule 315 is in effect.
9. If entered in Doubles bowlers must also enter Singles and vice versa on their original entry.
10. Team captains must check in 30 minutes prior to their scheduled time to bowl.
11. If a bowler is late the bowler receives a score of zero (0) for each frame missed. Substitutions are allowed and will bowl in the same position as the absent bowler. No line-up changes.
12. The Board of Directors of the Greater Charleston USBC Association will have the right to hear and decide on all protests arising during the tournament. Any protest affecting eligibility or playing rules must be confirmed in writing within twenty-four (24) hours.
13. The 10 pin rule, 319a.2, does not apply.
14. Proper attire should be worn. Shorts will be allowed provided they are of a proper length. Holes and tears in clothes will not be allowed. No cell phones or other electronic devices will be allowed during competition.
